Explanatory notes:

1. As a member of the Glovers Trust you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak at and vote at this meeting. You can only appoint a proxy using the procedures set out in these notes.
2. Appointment of a proxy does not preclude you from attending the meeting and voting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.
3. A proxy needs to be a member of the Glovers Trust and must attend the meeting to represent you. To appoint as your proxy a person other than the Chairman of the meeting, insert their full name where indicated. If you sign and return this proxy form with no name inserted, the Chairman of the meeting will act as your proxy. Where you appoint someone other than the Chairman as your proxy, you are responsible for ensuring that they attend the meeting and are aware of your voting intentions.
4. You are responsible for directing your proxy on how you wish them to vote. If your proxy votes in a way that you have not directed them to do, the votes will still be counted and the outcome of the vote will stand.
5. To appoint a proxy using this form, it must be completed and signed then sent or delivered to the address above to arrive no later than (insert time and date). Any proxy applications received after this will not be authorised.
6. A certified copy of any power of attorney or any other authority under which this proxy form is signed must be included with the proxy form (only if applicable).
