Finance Update

Membership Solution

The membership solution configuration is progressing well. All members and former members are now in the solution but we will probably need to re-visit our numbering system as the configuration appears to work in a way that a membership number sticks with a member for life, irrespective of whether they have renewed or not - they simply become active or inactive. We have grouping mechanisms in place to separate the categories and SB has discovered that we can apply different alpha-numeric prefixes to the different categories if we wish.

Trello Collaboration App:

JH stated that this App could be used but it was thought that it was not suitable for everyone. Further investigation required.

Any Other Business:

JH commented on the email that was to be released from Glovers Trust to the media on the current situation at YTFC. It was agreed to release

There was a discussion on if no deal could be reached by any potential investor of YTFC, what could Glovers Trust do to mitigate any winding up of club. Crowd funding was a suggestion, donations, or a Newport County/Exeter scenario after they went into administration. A plan of action by the Glovers Trust needs to be drawn up. It was decided to contact Exeter Alliance and Supporters Direct for their Advice.
