SAG meeting.

Ian had spoken to Heather McGinley from the Charlton trust who had been their chair person for several years. She had pointed Ian in the direction of the podcast about Bury and what had happened there and certain individuals who should never be allowed any where near the dealings of football clubs. Heather had also stated that she and Charlton trust would be happy to support YTFC trust in any way they could.

Ross then spoke about a Zine he was writing and was wondering if the trust could help out with some costings for it to be put to print. It was agreed he would get some quotes first for a print run and then the trust would consider it. Mike then gave some advice that his Father was in the print industry where several of his work colleagues were YTFC fans and may be able to do the print run at cost. Mike was going to talk to his father about the possibilities.

Adam and Steve had been tidying up the membership and how many actual members owed membership costs. Brendon had replied that some of those members were on a fee holiday because of a decision made by the former trust board not to charge due to the restraints of covid 19.

There was then a short discussion on membership cards. Should we be looking in upgrading and investing in an up-market type more like a credit/debit card which would look more professional.

Adam going to look into it and get some quotes for going down this route.
